

**TOWN OF DOYLE

ORDINANCE NO. 2021-02  
ESTABLISHMENT OF MUNICIPAL WARD BOUNDARIES**

**WHEREAS**, following each decennial census each County Board is required to create Supervisory election districts that are substantially equal in population, and

**WHEREAS**, the 2020 decennial census has been completed by the United States Department of Census, and

**WHEREAS**, the Town Board has received and reviewed the Barron County Board of Supervisors Tentative Supervisory District Plan and has made a good faith effort to accommodate the tentative county plan, and

**WHEREAS**, the Tentative Supervisory District Plan creates two supervisory districts within the Town of Doyle described as District #15 consisting of Ward 1 and District #24 consisting of Ward 2, and

**NOW, THEREFORE, BE IT RESOLVED** the Town Board of the Town of Doyle hereby establishes two wards for the Town of Doyle as follows:

**Ward One:**

Portion in Supervisory Dist 15: That portion of the **Town of Doyle** lying S & E of the following described line: Beginning at the W town line at the intersection of 18 ½ Ave, thence E along 18 ½ Ave to the intersection of 25 ½ St, thence N along 25 ½ St to the intersection of 19<sup>th</sup> Ave, thence E along 19<sup>th</sup> Ave to the intersection of 26 ½ St, thence N along 26 ½ St to the intersection of 19 ½ Ave, thence E along 19 ½ Ave to the intersection of 27 ½ St, thence N along 27 ½ St to the intersection of CTH C, thence W along CTH C to the intersection of 27<sup>th</sup> St/CTH NN, thence N along 27<sup>th</sup> St/CTH NN to the intersection of 27<sup>th</sup> St/STH 48, thence continuing N along 27<sup>th</sup> St/STH 48 to the N town line and there ending.

**Ward Two:**


Portion in Supervisory Dist 24: That portion of the **Town of Doyle** lying N & W of the following described line: Beginning at the W town line at the intersection of 18 ½ Ave, thence E along 18 ½ Ave to the intersection of 25 ½ St, thence N along 25 ½ St to the intersection of 19<sup>th</sup> Ave, thence E along 19<sup>th</sup> Ave to the intersection of 26 ½ St, thence N along 26 ½ St to the intersection of 19 ½ Ave, thence E along 19 ½ Ave to the intersection of 27 ½ St, thence N along 27 ½ St to the intersection of CTH C, thence W along CTH C to the intersection of 27<sup>th</sup> St/CTH NN, thence N along 27<sup>th</sup> St/CTH NN to the intersection of 27<sup>th</sup> St/STH 48, thence continuing N along 27<sup>th</sup> St/STH 48 to the N town line and there ending.

**BE IT FURTHER RESOLVED** that the Town Board of the Town of Doyle does hereby designate the polling place for each ward to be the Town of Doyle Town Hall located at 2248 27<sup>th</sup> Street, Rice Lake WI.
